RE: Reappointment of Gary V. Scales as Judge Pro Tempore

I am requesting Chief Justice Rebecca White Berch reappoint Gary V. Scales as full-time Judge Pro Tempore for the Superior Court in Gila County for the period of July 1, 2011 to June 30, 2012. Judge Scales' current term expires June 30, 2011.

Gary Scales was appointed as full-time Judge Pro Tempore on May 1, 2010, to prepare for the retirement of Judge Peter DeNinno in July 2010. Currently he is assigned minor dependency, child support enforcement, criminal and domestic relations cases, though he also handles other matters as needed.

Judge Scales' regular full-time salary is included in the county general fund budget for the current fiscal year. The County receives reimbursement from the State from the Family Law Commissioner program for Judge Scales' time in processing child support enforcement cases. *(This fiscal year through January the County has received back approximately \$43,650 for his services.)*

I am requesting Chief Justice Rebecca White Berch reappoint Peter J. DeNinno as a Judge Pro Tempore for the Superior Court in Gila County for the period of July 1, 2011 to June 30, 2012. Judge DeNinno's current term expires June 30, 2011.

Peter DeNinno served as a part-time judge pro tempore from January 1996 until his retirement in July 2010. He was primarily assigned minor dependency and child support enforcement cases, though he also handled a limited criminal and domestic relations caseload and other matters as needed. He is now assigned on an 'as-needed' minimal basis.

Judge DeNinno is compensated at a superior court judge's hourly rate, and serves only occasionally. Compensation is currently included in the general fund budget and will be requested for FY 12..
