Dear Sirs and Madams:

The Payson Regional Constable's Office has prepared its 2009 Annual Report for your review. In mid-2009, the Gila County Finance Department Director, Richard Gaona, suggested to then Constable Sam Brewer that future annual reports be prepared to reflect fiscal year comparisons instead of calendar year comparisons. At the beginning of 2009, a new computer database was created for use by the Globe and Payson Constable's offices. Unfortunately, the database had several issues that hindered the production of this Report in a timely manner.

Because the change from calendar year to fiscal year reporting overlaps, this Report includes the statistics for calendar year 2009, as well as comparison statistics for fiscal years 2007-2008 and 2008-2009. Future Annual Reports will reflect fiscal year only statistics.

Service fees collected in calendar year 2009 decreased by **14.29%** from that of 2008, while the volume of papers received in 2009 increased by **2.34%**. Miles driven also decreased by **3.59%** from that of 2008.

Service fees collected for fiscal year July 1, 2008 through June 30, 2009 decreased **5.30%** from that of fiscal year July 1, 2007 through June 30, 2008, while the volume of papers received also decreased **4.56%**. Miles driven during this period also decreased by **6.19%**. We believe that the beginning of the economic turndown may possibly be related to these decreases.
