

If you are receiving operating funds, your contract (Grant Agreement) will be e-mailed to your agency for signature, and promptly returned to ADOT. Your application will be part of this contract, and is non-negotiable. It **MUST** be fully executed prior to submitting invoices, or being reimbursed.
