Dear Sirs and Madams:

The Payson Regional Constable's Office has prepared its Fiscal Year 2011-2012 Annual Report for your review. This Report includes the statistics for 2011-2012, as well as a two year comparison which includes the 2010-2011 totals.

Service fees collected in fiscal year 2011-2012 decreased by **34.30%** from that of fiscal year 2010-2011, while the volume of papers received decreased by **18.80%**. Miles driven also decreased by **3.84%** from that of 2010-2011.

The decrease in the number of received papers to serve this fiscal year, we believe, is tied to the economic turndown.
