Thanks for the follow up, we'll have 4 original Memorandum of Agreement's (MOA) prepared, 1 for us- 3 for you. I see your reasoning for signing last since the County would be the lead participant in most situations in and around your area of operation. Since the Army Recruiting Command is the sponsoring agency and we're dealing with a Major General whose in Command of the Army's Recruiting Operations for the United States, to include Puerto Rico and the Virgin Islands; this should identify the Army as the lead organization. The MOA is then considered a "blank document" till signed by the participating agency. This is why the General doesn't sign till it's signed by the other agency.
