Discussion of a potential site for new Gila County animal shelter and options with the City of Globe for acquiring the necessary land for project.

Background Information

Currently, Gila County operates an animal shelter in Globe located next to the cemetery that is owned by the City of Globe. The property is owned by the City of Globe and the building of which the County operates is owned by the Humane Society. Gila County pays rent to the Humane Society for use of the building. The building is dilapidated and has several structural deficiencies.

In 2013, the City of Globe Manager notified the Director of the Gila County Health and Emergency Services Division that it will be necessary for Gila County to vacate the property in the near future for expansion to their cemetery.

Evaluation

The property is adjacent to the City of Globe Public Works yard. The County is looking at 2 acres that will be jointly held in the name of the City and County so that there will not be any questions by future Councils or Boards. The current left field fence on one of the baseball fields will be removed as well as one of the lights in order to accommodate a road. The County will have to do the excavation of the property and the City will be responsible for running water and sewer to the property and, at that point, the County would consider everything to be even. In discussions between the County Manager and the Public Works Division Director, it was acknowledged that because the City does not have any capital to put into the structure, it was agreed that the Board could consider having the County pay for the building and the City could pay back the County their 50% over a period of years. This will allow the County to move forward with the project.

Conclusion

This two acre piece of property would provide Gila County with enough space to build a new animal shelter and provide a strong collaboration with the City of Globe.

Serious consideration should be given to acquire this piece of property so a new animal control facility can be planned for and built.

Recommendation

Based on the information supplied by the Public Works Division Director, the Health and Emergency Services Division Director recommends that the Board of Supervisors consider the acquisition of this property as the first step in the process of building a new animal shelter.

Background Information

The Tonto National Forest has opened a comment period regarding a proposed Plan of Operations (Plan) for the Resolution Baseline Hydrological and Geotechnical Data Gathering Activities Submitted by Resolution Copper Mining, LLC (Resolution). The project is proposed on lands within the Tonto National Forest on the Mesa and Globe Ranger Districts in Pinal County. This project is approximately six miles north and west of the town of Superior, and is located north of the Hewitt Station Road in the Superstition foothills.

Resolution proposes to conduct baseline hydrologic, geochemical, and geotechnical data in order to provide baseline information on these aspects of the environment over an area being considered for a potential tailings storage site related to Resolution's proposed General Plan of Operations. Resolution is entitled to conduct operations that are reasonably incidental to exploration and development of mineral deposits on its unpatented mining claims pursuant to U.S. Mining Laws.

The total project area proposed for the Baseline Activities, including new construction activity, road improvements, use of short term temporary access roads and existing road surfaces is approximately 93 acres. Proposed new construction disturbance would occur on a total of 31.74 acres, all Tonto Forest land.

Tonto National Forest has determined that an Environmental Analysis (EA) is the appropriate level of analysis for this proposed plan. This EA will identify the activities in the proposal as the "proposed action," and identify alternatives in response to issues that may be identified during the NEPA scoping process. The Tonto Forest is initiating scoping efforts to identify those issues and questions to be considered in the evaluation.

Comments should be within scope of the proposed action, have a direct relationship to the proposed action, and include supporting reasons for the Responsible Official to consider. Comments are due by 4:30 pm, on Monday, June 23, 2014.

<u>Evaluation</u>

Resolution Copper has spent the past ten years and several million dollars developing plans to access the additional copper ore body that was discovered in 1996. The economic benefit to the local area as well as to Arizona will continue for at least another 50 years. The next phases of environmental studies, construction, operation and reclamation, will create an estimated economic benefit of \$20 billion in federal, state and local tax revenue, more than \$14 billion in wages, and a total economic impact of more than \$61 billion over its 60 year lifespan.

As part of the engineering and environmental phase, this proposed action gathers data on the future potential tailings storage site. Resolution has been engaged in ongoing discussions with local private land owners, and the proposed location addresses the local residents' concerns and issues

Conclusion

Resolution Copper will have an economic benefit to Gila County, and as such, Gila County has a special interest in this proposal. Providing comments to this scoping phase of the Environmental Assessment will be considered part of the public record of this analysis by the Tonto Forest as it moves forward in this project, and will ensure that Gila County is kept informed as the process continues.

Dear Forest Supervisor Bosworth,

In response to the request for public comment regarding the proposed Plan of Operations (Plan) for the Resolution Baseline Hydrological and Geotechnical Data Gathering Activities, the Gila County Board of Supervisors would like to provide the following comments. Although not located with the geographic boundaries of Gila County, Resolution Copper has and will continue to create an economic benefit to Gila County, and as such, Gila County has a special interest in this proposal. We are a rural county with a population of 53,144, of which 12% are unemployed and 21% are living at or below 200% of the federal poverty level.

Within this project, the proposed new construction would create disturbance on a total of 31.74 acres of previously undisturbed Tonto Forest Land, while the majority of the proposal would impact another 61.24 acres of previously disturbed land or existing roadways. Given that the Tonto Forest is comprised of nearly three million acres, this represents an incredibly small amount of impacted land, for the return benefit of gathering the baseline data necessary to advance this project to the next stage.

Resolution is entitled to conduct operations that are reasonably incidental to exploration and development of mineral deposits on its unpatented mining claims pursuant to U.S. Mining Laws. In addition, we believe that this proposed Plan of Activities is consistent with the Tonto National Forest Land and Resource Management Plan (LRMP) of 1985 as amended, and that the mineral exploration, development and operational activities as outlined in this proposed plan will be conducted in a manner that minimizes adverse environmental impact on the Tonto Nation Forest surface resources as codified in 36 CFR Part 28.

As part of the engineering and environmental phase, this proposed action gathers data on the future potential tailings storage site. Resolution Copper, LLC has been engaged in ongoing discussions with local private land owners, and the proposed location addresses the local residents' concerns and issues. After reviewing the

Resolution Copper has spent the past ten years and several million dollars developing plans to access the additional copper ore body that was discovered in 1996. The economic benefit to the local area as well as to Arizona will continue for at least another 50 years with an estimated economic benefit of more than \$61 billion over the expected 60 year lifespan of the operation, including an estimated \$20 billion in federal, state and local tax revenue and more than \$14 billion in wages.

In Gila County, we recognize and understand the importance of protecting our natural resources while providing opportunities and access to those whose livelihoods depend on resources located on federal land as well as access for multiple use, multi-cultural activities, and multi-recreational opportunities to the public. Historically, our economy and our residents have depended heavily upon resource-based industries and, more recently, upon recreation opportunities on federal land. We appreciate that we must take care of the land, but we need to be able to use the land to take care of ourselves.

The Gila County Board of Supervisors thanks you for the opportunity to comment and requests to be kept informed and included in the process as this analysis continues.

The Tonto National Forest (Forest) welcomes your comments on a proposed Plan of Operations (Plan) for the Resolution Baseline Hydrological & Geotechnical Data Gathering Activities, submitted by Resolution Copper Mining, LLC (Resolution). Resolution proposes to conduct baseline hydrologic, geochemical, and geotechnical data gathering activities (Baseline Activities) on National Forest System lands administered by the Forest. The project is proposed on the Mesa and Globe Ranger Districts in Pinal County, Arizona, approximately 6 miles north and west of the town of Superior, in the following non-contiguous areas of National Forest System lands in the following townships, ranges and sections of the Gila and Salt River Baseline and Meridian (Figure 1):

Township 1 South, Range 11 East in portions of Sections 13, 23-27 and 35-36; Township 1 South, Range 12 East in portions of Sections 19, 20 and 28-33; Township 2 South, Range 11 East in portions of Sections 1 and 2; and Township 2 South, Range 12 East in portions of Section 6.

The proposed Plan is subject to the Project-Level Pre-decisional Administrative Review Process under Title 36 Code of Federal Regulations (CFR) Part 218, Subparts A and B.

Purpose and Need: The purpose of the proposed action is to collect hydrologic, geochemical, and geotechnical data in order to provide baseline information on these aspects of the environment over an area being considered for a potential tailings storage site related to Resolution's proposed General Plan of Operations. Resolution is entitled to conduct operations that are reasonably incidental to exploration and development of mineral deposits on its unpatented mining claims pursuant to U.S. Mining Laws. Under regulations of the U.S. Secretary of Agriculture, Resolution must conduct mining operations in accordance with the requirements found at 36 CFR Part 228A and in accordance with a plan of operations that has been approved by the Forest Service. The need for the proposed Federal action is for compliance with the requirement that the Forest Service respond to a proposed plan of operations to conduct mining operations on National Forest System lands pursuant to U.S. Mining Laws.

Proposed Action: Resolution's proposed action consists of hydrologic, geochemical, and geotechnical baseline data gathering activities including construction of hydrologic testing and monitoring wells and well pads, installation of geotechnical drill holes and piezometers, construction of geotechnical test trenches, improvements to existing roads, and maintenance of existing roads in the data gathering activities area (Figure 2). Data to be obtained from hydrologic testing and monitoring wells include depth to groundwater level, rock characteristics and geochemistry of drill cuttings, aquifer hydraulic parameters, and chemical quality of



groundwater. Geotechnical drill holes and piezometers would be used to define the baseline soil and bedrock hydrological and geotechnical conditions (depth to water). Test trenches would be used to identify the physical properties of the soils. Specifically, Resolution's proposed Baseline Activities are the following:

- 1) Construct 16 drill sites to accommodate a total of 16 groundwater testing and monitoring wells that would impact approximately 4.21 acres;
- 2) Complete 41 geotechnical drill holes and piezometer installations that would impact approximately 0.27 acres;
- 3) Construct geotechnical test trenches at 33 sites that would impact approximately 1.32 acres;
- Complete roadway improvements to facilitate access to data gathering sites on approximately 12.26 miles of existing roads and previously disturbed areas proposed to be used as temporary access roads on National Forest System lands that would impact approximately 16.42 acres;
- 5) Construct contractor laydown yards that would impact approximately 2.19 acres;
- 6) Conduct road maintenance for access to drill sites with monitoring wells or piezometers installed on National Forest System lands; and
- 7) Use of short term temporary access roads to bring a tracked rig to off-road locations, which would impact approximately 7.33 acres.

The total project area proposed for the Baseline Activities, which takes into account new construction activity, road improvements, use of short term temporary access roads and existing road surfaces requiring no improvements is approximately 92.98 acres. Proposed new construction disturbance would occur on a total of 31.74 acres, all on National Forest System lands. Resolution's proposed occupancy and authorization periods, and proposed reclamation timeframes for Baseline Activities are presented in Table 1.

Access to the proposed project area would be gained from U.S. Highway 60. Approximately 38.44 miles of existing forest roads, 3.39 miles of previously disturbed areas proposed to be used as temporary access roads, and 6.05 miles of short term temporary access roads on National Forest System lands would be used to gain access to the proposed data gathering sites. Approximately 12.26 miles of the proposed access roads would require improvements and maintenance and be graded for drill rigs and support vehicles to traverse them safely; this includes Forest Roads 252, 518, 1903, 1904, 1907, 1908, 1909, 1918, 2359, 2364, 2371, 2387 and 3713 and four segments of previously disturbed areas to be used as temporary access roads. In some places, forest roads may need to be widened to accommodate the equipment and drill rigs. Approximately 3.39 miles of short term temporary access roads would be used to access test trenches and geotechnical sites, for a period of about two days.

Federal Mining Laws and Forest Plan Direction: The statutory right of Resolution to mine mineral resources on federally administered lands is recognized in the *General Mining Law of 1872* and is consistent with *Tonto National Forest Land and Resource Management Plan* (LRMP) of 1985, as amended. Surface management regulations, codified in *36 CFR Part 228*, require that all mineral exploration, development, and operational activities be conducted in a manner that minimizes adverse environmental impacts on National Forest surface resources (*36 CFR Part 228.8*). The Forest Service is required to ensure that the proposed Plan is in compliance with *36 CFR Part 228* and to analyze impacts of proposed activities in accordance with requirements of the *National Environmental Policy Act* (NEPA).

Forest-wide management direction pertinent to minerals is to "Support environmentally sound energy and minerals development" (page 22, LRMP). Resolution's proposed project is located in Plan Management Areas (MA) 2F and 3I. Direction for minerals in MA 2F and 3I includes processing operating plans as needed. Other applicable forest-wide goals, objectives, and management area standards, including protection of air, culture resources, recreation opportunities, soils, visual resources, water and wildlife, are found in LRMP (pages 35 through 51).

NEPA Review: Based on initial review, it has been determined that an *Environmental Assessment* (EA) would be the appropriate level of analysis for the proposed Plan. This EA will identify the activities proposed in the Plan as the "proposed action." It will also identify alternatives to the proposed action in response to issues that may be identified during the NEPA scoping process.

In accordance with the requirements of NEPA, the EA will include an evaluation of the *No Action* alternative. Under the *No Action* alternative, the Baseline Activities would not be conducted, however due to the statutory rights afforded by the U.S. Mining Laws; the Forest Service cannot select the *No Action* alternative as a preferred alternative. The purpose for incorporating the *No Action* alternative is to provide a baseline from which impacts of other alternatives can be evaluated. The analysis documented in the EA will determine the effects of each alternative on resources identified during scoping and identify appropriate mitigation and monitoring measures to minimize adverse impacts to those resources.

Based on the environmental analysis and disclosure documented in the EA, the Forest Service will:

- 1. Decide whether to select the Baseline Activities as proposed or modified, or as described in an alternative developed during the NEPA process;
- 2. Determine what mitigation measures are needed; and
- 3. Determine what monitoring may be required.

This NEPA review addresses Resolution's proposal to collect hydrologic, geochemical, and geotechnical data in order to provide baseline information over an area being considered for a potential tailings storage site. Resolution has submitted other minerals-related proposals to the Forest, such as the General Plan of Operations. However, the impacts of that and other proposals would be evaluated in separate NEPA reviews. Resolution's Baseline Activities Plan proposes

to collect baseline information in order to inform whether aspects of Resolution's proposed General Plan of Operations are feasible.

Requests for Comments: You are encouraged to provide comments on the proposed project. The Forest is initiating scoping efforts to identify those issues and questions to be considered in the evaluation.

There are a variety of ways to learn about the proposed project and provide scoping comments. A public open house will be held in the Multi-Purpose room at Superior Junior/Senior High School located at 100 Mary Drive in Superior, Arizona. Comments may be provided to the Forest Service at the open house using comment forms that will be available at the meeting. Comments may also be submitted before or after the open house by mail, email, fax, or through the Forest web page located at http://www.fs.usda.gov/projects/tonto/landmanagement/projects.

Specific written comments (*36 CFR Part 218.2*) on the proposed project will be accepted for 30 calendar days following publication of this notice in the newspaper of record, the *Arizona Capitol Times;* if the comment period ends on a Saturday, Sunday, or Federal holiday, comments will be accepted until the end of the next Federal working day. The publication date in newspaper of record is exclusive means for calculating comment period. Those wishing to comment should not rely upon dates or timeframe information provided by any other source.
