Presentation on the National Association of Counties (NACo) Prescription and Health Discount Program.

Background Information

The NACo Prescription & Health Discount Program provides relief to uninsured and underinsured Americans who face high prescription and health costs. The program is free to NACo member counties and it has been offering real savings to county residents across the country since 2004. Gila County has participated since 2009.

The Prescription & Health Discount Program, which is administered by CVS Caremark, includes discounts on prescriptions, vision care, LASIK & PRK vision procedures, hearing aids & screenings, prepaid lab work, prepaid diagnostic imaging and diabetic supplies. A resident can begin saving on prescriptions as soon as he/she receives a free prescription discount card. To add additional health services, memberships are available on a monthly or annual subscription basis for both individuals and families and discounts are available immediately upon enrollment. For individuals, the fee is \$6.95 a month or \$69 a year. For families, the fee is \$8.95 a month or \$79 a year.

The NACo Prescription Discount Card program helps residents save money on their prescription medications any time their prescriptions are not covered by insurance. The free cards are distributed in the sponsoring county and may be used at any participating retail pharmacy. County residents can also print a card from the Internet. The discount card is not insurance.

Average savings are 24%; some discounts may be more, and some less, depending on the drug and quantity purchased. Cardholders may save on pet prescriptions also used to treat human conditions at participating pharmacies.

The cards may be used by all county residents regardless of age, income or existing health coverage. There is no enrollment form, no membership fee and no restrictions or limits on frequency of use. Cardholders and their family members may use the card any time their prescriptions are not covered by insurance.

Set a Public Hearing Date for Deannexation/Annexation for Towns of Star Valley and Payson.

Background Information

On August 8, 2014, the Gila County Clerk of the Board (COB) received an email from Tim Wright, Town of Payson Attorney, advising the County that the Town of Star Valley and Town of Payson are collaboratively working to deannex 760 acres of Forest Service land from Star Valley into Payson.

A.R.S. §9-471.02 provides the requirements for deannexation/annexation of land from one municipality to another municipality.

In accordance with statutory requirements, on August 13, 2014, the Town of Star Valley filed Ordinance No. O 14-02 with the COB, and August 15, 2014, the Town of Payson filed Ordinance No. 853 with the COB.

Evaluation

Ordinances were adopted by the Mayors and Common Councils of the Towns of Star Valley and Payson and they were filed with the COB in accordance with statutory requirements.

The next step in the statutory process is for the Board of Supervisors to establish a public hearing date, after which the Town of Star Valley and Town of Payson will be provided notice of said public hearing. A.R.S. §9-471.02(D) states, "The ordinance passed by each governing body shall be filed with the board of supervisors which shall set a hearing date of not less than thirty nor more than sixty days from the date of the filing of the ordinances and shall notify the governing body of each city or town of the hearing date at least thirty days prior to the date."

Conclusion

It is now the time for the Board of Supervisors to set a public hearing date to consider deannexing 760 acres of Forest Service land from the Town of Star Valley to the Town of Payson.

Recommendation

It is recommended that the Board of Supervisors set a date of Tuesday, September 16, 2014, to hear public comments with regard to requests of the Town of Star Valley and Town of Payson for said deannexation/annexation of land as specified in the ordinances submitted by both Towns.

**ORDINANCE NO. O 14-02**

**AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF STAR VALLEY, ARIZONA, DEANNEXING CERTAIN LAND GENERALLY TO THE WEST OF THE SOUTHWEST CORNER OF THE TOWN BOUNDARIES (PORTIONS OF SECTIONS 6 AND 7) TO THE TOWN OF PAYSON PURSUANT TO A.R.S. § 9-471.02.**

**WHEREAS**, the Town of Star Valley's western boundary is adjacent to the Town of Payson's eastern boundary; and

**WHEREAS**, the Town of Payson is considering annexing a parcel of private property (known as "Fox Farm") to the east of Payson that is surrounded on three sides by national forest land located within Star Valley; and

**WHEREAS**, the only vehicular access to Fox Farm is from Payson, passing through the forest service land located within Star Valley; and

**WHEREAS**, Star Valley and Payson believe it is prudent for planning, maintenance, and orderly development purposes that the vehicular access for Fox Farm be in the same municipality as Fox Farm itself; and

**WHEREAS**, Payson believes the annexation of Fox Farm into Payson could be done in a much more orderly, simpler, and a smaller land mass area if the land immediately to the west of Fox Farm were within Payson's boundaries; and

**WHEREAS**, Payson is willing to annex the forest service land immediately to the west of Fox Farm containing the vehicular access to Fox Farm ("the Land") if Star Valley deannexes the Land (see diagram in Exhibit A depicting the Land and Exhibit B containing a legal description of the Land); and

**WHEREAS**, Star Valley and Payson desire to follow the procedures set forth in A.R.S. § 9-41.02 to accomplish this deannexation/annexation,

**NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF STAR VALLEY, ARIZONA, ORDAIN AS FOLLOWS:**


- Section 1. The Town of Star Valley will deannex the Land, contingent upon the Town of Payson passing an Ordinance to annex the Land. A legal description of the Land is attached as Exhibit B.
- Section 2. The annexation set forth in Section 1 is contingent upon the fulfillment of all of the conditions of A.R.S. § 9-471.02 prior to December 31, 2014.
- Section 3. The Clerk of the Town of Star Valley is directed to coordinate with the Clerk

of the Town of Payson to comply with the requirements of A.R.S. § 9-471.02.

Section 4. That the Town of Star Valley, acting through its appropriate officers, employees, and officials, is hereby authorized to take all other actions necessary or appropriate to carry out the purposes of this Ordinance.





WHEREAS, the Town of Star Valley's western boundary is adjacent to the Town of Payson's eastern boundary; and

WHEREAS, the Town of Payson is considering annexing a parcel of private property (known as "Fox Farm") to the east of Payson that is surrounded on three sides by national forest land located within Star Valley; and

WHEREAS, the only vehicular access to Fox Farm is from Payson, passing through the forest service land located within Star Valley; and

WHEREAS, Star Valley and Payson believe it is prudent for planning, maintenance, and orderly development purposes that the vehicular access for Fox Farm be in the same municipality as Fox Farm itself; and

WHEREAS, Payson believes the annexation of Fox Farm into Payson could be done in a much more orderly, simpler, and a smaller land mass area if the land immediately to the west of Fox Farm were within Payson's boundaries; and

WHEREAS, Payson has been informed that Star Valley desires and will agree by Ordinance to deannex the forest service land immediately to the west of Fox Farm containing the vehicular access to Fox Farm ("the Land") (see diagram in Exhibit A depicting the Land and Exhibit B containing a legal description of the Land); and

WHEREAS, Payson desires to annex the Land; and

WHEREAS, Star Valley and Payson desire to follow the procedures set forth in A.R.S. §9-471.02 to accomplish this deannexation/annexation,

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, ORDAIN AS FOLLOWS:

Section 1. The Town of Payson will annex the Land, contingent upon the Town of Star Valley passing an Ordinance to deannex the Land. A legal description of the Land is attached as Exhibit B.

Section 2. The annexation set forth in Section 1 is contingent upon the fulfillment of all of the conditions of A.R.S. §9-471.02 prior to December 31, 2014.







9-471.02. Deannexation of land from one municipality and annexation to another municipality; deannexation of right-of-way from a municipality to a county

A. Notwithstanding any other law, territory may be deannexed and severed from one city or town and annexed to another city or town under this section if the territory that is deannexed is contiguous to the city or town that annexes the territory.

B. The governing body of a city or town that intends to deannex the territory shall by ordinance set forth the legal description of the territory and shall declare the deannexation of the territory contingent on the fulfillment of the conditions of this section.

C. The governing body of the city or town that intends to annex the territory shall by ordinance set forth the legal description of the territory and shall declare the annexation of the territory contingent on fulfillment of the conditions of this section.

D. The ordinance passed by each governing body shall be filed with the county board of supervisors which shall set a hearing date of not less than thirty nor more than sixty days from the date of the filing of the ordinances and shall notify the governing body of each city or town of the hearing date at least thirty days prior to the date.

E. The governing body of the city or town desiring to deannex territory shall notify by letter the owner of any real property in the territory to be deannexed at least twenty days before the hearing by the county board of supervisors. The notification shall specify that the area is to be deannexed and annexed to another city or town and that the property shall continue to be subject to any tax lawfully assessed against it for the purpose of paying any indebtedness lawfully contracted by the governing body of the city or town while the property was within the corporate limits. The letter shall state that the property owner may protest the action by letter to the county board of supervisors before the hearing or in person at the hearing. If property owners of fifty-one per cent or more of the land area of the territory to be deannexed protest the action, the county board of supervisors shall deny the deannexation of the territory. If the action is denied it may not be resubmitted to the county board of supervisors for at least one year following the denial.

F. On determining that the requirements of this section have been satisfied, on the holding of the public hearing and on determination that the protests filed are insufficient as defined by this section, the county board of supervisors shall order that the territory be deannexed from one city or town and that the same territory be annexed to another city or town as specified in the two ordinances authorized by this section.

G. The land deannexed and annexed shall not be exempt from the payment of any taxes lawfully assessed against it for the purpose of paying any indebtedness lawfully contracted by the corporate authorities of the city or town while the land was within the limits of the city or town and that remains unpaid, and for the payment of which the land could be lawfully taxed.

H. If the governing body of the city or town that has deannexed territory levies a tax on the property within the city or town for the purpose of paying indebtedness incurred before the deannexation, or any part thereof, and interest thereon, the governing body may levy a tax at the same rate and for the same purpose on the deannexed territory. If the owner of any deannexed territory pays off and

discharges a portion of the indebtedness equal in amount to the same proportion of the indebtedness that the assessed value of the owner's land bears to the entire assessed value of all the property subject to taxation for the payment of the indebtedness, calculated according to the last assessment previous to the payment, the land shall be exempted from further taxation to pay the indebtedness. On payment being made, the canceled bonds or other evidences of payment of the portion of the indebtedness shall be deposited with the clerk of the city or town and a certificate shall be given by the clerk stating that the payment has been made.

I. Notwithstanding any other law, a public right-of-way that is partially located within a city or town and partially located within the unincorporated area of a county may be deannexed and severed from the city or town and returned to the county pursuant to section 9-471.03. The county board of supervisors shall notify the city or town if the order of the county board of supervisors ordering the deannexation of the public right-of-way is approved.

J. A copy of the order of the county board of supervisors ordering the deannexation and annexation of any land described in any city or town, certified by the clerk of the board, shall be filed for record in the recorder's office of the county in which the land is situated. The record, or a copy of the order or decree, certified by the clerk of the board, shall be proof of the deannexation and annexation of the land.

Contribution for economic development; and §11-254.04. Expenditures for economic development; definition.

**GILA COUNTY COMMUNITY AGENCY AND ECONOMIC DEVELOPMENT  
FUNDING PROCEDURES**

**I. DEFINITIONS:**

**II. PROCEDURES:**

**A. General Requirements and Objective**

Annually, County staff shall develop a Community Agency and Economic Development Funds list consisting of non-profit entities (community agencies), cities, towns and other governmental agencies to be considered for funding in the next annual budget. The list shall be made up of agencies funded in the previous budget year and any new or known requests for the upcoming budget year.

The list is for staff purposes only and will not be published in the budget, but will be used each year to establish the proposed funding levels for the budget line items of Constituent Funds – Districts I, II, and III, the Community Agency Fund, and the Community/Economic Development Fund. Agencies not included on the list may be considered for funding depending upon the availability of funds.

**B. Consideration for Funding**

Eligible recipients of funding are limited to non-profit agencies, cities, towns or other governmental agencies. The purpose of the funding shall be to provide services to the public which Gila County is authorized to provide in conformance with Arizona Revised Statute §11-251. Powers of the board; or for economic development activities which the Gila County Board of Supervisors determines are for the benefit of the public in conformance with Arizona Revised Statute §11-254. Contribution for economic development; and §11-254.04. Expenditures for economic development; definition.

When a request is being considered for funding, Gila County may, with mutual consent of the recipient, provide in-kind services, man power, equipment, and material in lieu of funding to meet the needs of specific requests.

### C. Funding Process

1. Funding requests must be submitted to the Gila County Finance Department on the letterhead of the non-profit entity, city, town or other governmental agency.
2. Gila County will provide an intergovernmental agreement, a memorandum of understanding or a contract which enumerates the specific services or activities to be funded and provided. The intergovernmental agreement, memorandum of understanding or contract must be signed by both parties.
3. Non-profit entities are defined as those enjoying federal tax exempt status with the Internal Revenue Service.
4. Proof of non-profit tax exempt status must be furnished with the intergovernmental agreement, memorandum of understanding or contract.

### D. Constituent Funds

Annually, Constituent Funds are appropriated for each of the three (3) members of the Gila County Board of Supervisors for use within their respective districts for purposes each Supervisor deems appropriate. While these discretionary funds can be used for a wide range of projects, services, and activities, each Supervisor is bound by Arizona law and Gila county policies in their use. For example:

1. The use of Constituent Funds to hire temporary employees is subject to all of Gila County's open and competitive recruiting, selection and hiring policies and procedures.
2. The use of Constituent Funds to support non-profit entities, cities, towns and other governmental agencies that provide services to the public which the Gila County Board of Supervisors is authorized to provide, or for economic development activities which are determined to benefit the public, are subject to the customary process and requirements of an intergovernmental agreement, memorandum of understanding or contract.
3. The use of Constituent Funds to purchase products, goods or services is subject to all Gila County open and competitive bidding and award policies and procedures.

4. Any other use of Constituent Funds not enumerated above is subject to prior approval of the Gila County Board of Supervisors.

#### E. Hiring Temporary Employees

1. Submit a "Request to Post" and a "Payroll Authorization" to the Gila County Human Resources Department. (Note: Allow a minimum of three (3) weeks to hire a temporary employee).

The "Request to Post" shall include:

- a) A description of the specific Gila County purpose and task to be accomplished
  - b) The job classification title and its salary, grade, and step.
  - c) The name of the department/division or elected office to whom the temporary employee will report (County elected official or department/division director will assign a direct supervisor).
  - d) The start and end date of the temporary position.
2. All temporary positions shall be posted and/or advertised for a minimum of five (5) regular working days.
  3. Hiring will be based upon the results of an interview and background check of the qualified applicants.
  4. The "effective date" of hire cannot precede the interview completion date.

**GILA COUNTY COMMUNITY AGENCY FUND, ECONOMIC DEVELOPMENT FUND  
AND CONSTITUENT SERVICES FUND PROCEDURES**

(Revised 8/26/14)

a. **DEFINITIONS:**

NONE

b. **PROCEDURES:**

A. General Requirements and Objective

Annually, County staff shall develop a Community Agency Fund, Economic Development Fund and a Constituent Services Fund list consisting of non-profit entities (community agencies), cities, towns and other governmental agencies to be considered for funding in the next annual budget. The list shall be titled the Potential Recipients of Economic Development Contributions and shall be made up of agencies funded in the previous budget years and any new or known requests for the upcoming budget year.

**Annually, after the adoption of the Annual Budget, the Board of Supervisors shall take official action to approve the Potential Recipients of Economic Development Contributions list and find and determine that the entities on the list are governmental entities or nonprofit corporations which enjoy and maintain federal tax exempt status and that any funds contributed to them will be used to benefit the public and that the funds will assist in the creation or retention of jobs or will otherwise improve or enhance the economic welfare of the inhabitants of Gila County.**

Agencies not included on the list may be considered for funding **with Board of Supervisors approval** depending upon the availability of funds.

B. Consideration for Funding

Eligible recipients of funding are limited to non-profit agencies, cities, towns or other governmental agencies. The purpose of the funding shall be for economic development activities which the Gila County Board of Supervisors determines are for the benefit of the public in conformance with Arizona Revised Statute §11-254.

Contribution for economic development; and §11-254.04. Expenditures for economic development; definition.

When a request is being considered for funding, Gila County may, with mutual consent of the recipient, provide in-kind services, staffing, operators, equipment, and material in lieu of funding to meet the needs of specific requests.

C. Community Agency Funds and Economic Development Funds

1. Annually, community agency and economic development funds are budgeted to support non-profit entities, cities, towns and other governmental agencies that are on the approved Potential Recipients of Economic Development Contributions list.
2. The use of community agency and economic development funds **shall comply with the following funding process:**
  - a. **Funding requests shall be submitted to the Gila County Finance Department on the letterhead of the non-profit entity, city, town or other governmental agency.**
  - b. **Funding requests shall contain the amount of the request, proof of current federal tax exempt status, an indication of the specific purposes for which the funding is to be used, and how the uses are consistent with the Arizona Revised Statutes §11-254 and §11-254.04 requiring that the uses are to benefit the public and will assist in the creation or retention of jobs or will otherwise improve or enhance the economic welfare of the inhabitants of Gila County.**
  - c. **Gila County will provide an intergovernmental agreement, a memorandum of understanding, or a contract, that enumerates the information required in paragraph C. 2. b. of this procedure, which will be placed on the next available Regular Meeting Board of Supervisors Agenda for consideration. The intergovernmental agreement, memorandum of understanding or contract shall be approved and signed by both parties to become effective.**

D. Constituent Services Funds

Annually, Constituent Funds are budgeted for each of the three (3) members of the Gila County Board of Supervisors for use within their respective districts for purposes each Supervisor deems appropriate. While these discretionary funds can be used for a wide range of projects, services, and activities, each Supervisor is bound by Arizona law and Gila County policies in their use. For example:

1. The use of Constituent Funds to hire temporary employees is subject to all of Gila County's open and competitive recruiting, selection and hiring policies and procedures. See Section E. Hiring Temporary Employees with Constituent Funds in these Procedures.
2. The use of Constituent Funds to support non-profit entities, cities, towns and other governmental agencies on the approved Potential Recipients of Economic Development Contributions list **shall comply with the following funding process:**
  - a. **Funding requests/letter agreements shall be submitted to a Gila County Board of Supervisors Member on the letterhead of the non-profit entity, city, town or other governmental agency.**
  - b. **Funding requests/letter agreements shall contain the amount of the request, proof of current federal tax exempt status, an indication of the specific purposes for which the funding is to be used, and how the uses are consistent with the Arizona Revised Statutes §11-254 and §11-254.04 requiring that the uses are to benefit the public and will assist in the creation or retention of jobs or will otherwise improve or enhance the economic welfare of the inhabitants of Gila County.**
  - c. **Funding requests/letter agreements submitted through individual Board of Supervisors will be reviewed and approved for payment by the Board Member and transmitted to the Finance Department for payment.**
3. The use of Constituent Funds to purchase products, goods or services is subject to all Gila County open and competitive bidding and award policies and procedures.
4. Any other use of Constituent Funds not enumerated above is subject to prior approval of the Gila County Board of Supervisors.

E. Hiring Temporary Employees with Constituent Funds

1. Submit a completed Request to Post form to the Gila County Human Resources Department. (Note: Allow a minimum of three (3) weeks to hire a temporary employee).

The Request to Post form shall include the following information:

- a) A description of the specific Gila County purpose and task to be accomplished.
  - b) The job classification title, grade, and salary.
  - c) The name of the department/division or elected office to whom the temporary employee will report. The County elected official or department/division director will assign a direct supervisor.
  - d) The start and end date of the temporary position.
2. All temporary positions shall be posted and/or advertised for a minimum of five (5) regular working days.
  3. Hiring will be based upon the results of an interview and background check of the qualified applicants.
  4. The “effective date” of hire cannot precede the interview completion date.
  5. Once the candidate has been selected, a Personnel/Payroll Authorization form shall be completed and submitted to the Human Resources Department and approved by the County Manager. No temporary employee shall be allowed to start work until this process is completed.

F. Requests For Non-monetary Support

- 1. Requests to provide services, staffing, operators, furniture, small equipment, and large mechanical equipment must be submitted to the County Manager’s office on the letterhead of the requesting non-profit entity, city, town or other governmental agency.**
- 2. Gila County shall provide an intergovernmental agreement, memorandum of understanding, contract or a letter agreement as appropriate, which enumerates the specific services, staffing, operators, furniture, small equipment, large mechanical equipment or material to be provided which must be approved and signed by both parties to become effective.**


