It is mutually agreed that the Intergovernmental Agreement referenced is amended as follows:

1. Pursuant to, Terms and Conditions, Provision Six (6), **Contract Changes**, Item 6.1, Amendments, Purchase Orders and Change Orders, the Agreement is hereby extended through March 31, 2018.
2. The Price Sheet of the original Agreement is hereby replaced with the revised Price Sheet of this Amendment. The total of the revised Price Sheet decreased from \$276,625.00 to \$217,613.00 due analyzing and updating the current salaries and removing one position. The line changes are the following:
 - 2.1 Core Medical Personnel & ERE decreased by \$43,879.74, from \$145,625.74 to \$101,746.00.
 - 2.2 Core Medical Services Delivered decreased by \$20,000.00, from \$67,900.00 to \$47,900.00.
 - 2.3 Support Services Delivered increased by \$10,294.00, from \$35,906.00 to \$46,200.00.
 - 2.4 Administration Services Personnel/ERE increased by \$41.00, from \$6,983.00 to \$6,942.00.
 - 2.5 Administration Services Delivered decreased by \$5,386.00, from \$20,211.00 to \$14,825.00.

ALL OTHER PROVISIONS OF THIS AGREEMENT REMAIN UNCHANGED.
