



AMENDMENT NO. 1 TO SERVICE AGREEMENT NO. 092215-1

The following amendments are hereby incorporated into the contract documents for the below stated project:

MAJOR REHABILITATION PROJECT HH#10435

COMMUNITY SERVICES-HOUSING

Effective September 23, 2015, Gila County and Rodriguez Constructions, Inc. entered into a contract whereby Rodriguez Constructions, Inc. agreed to provide labor and materials to perform the scope of work as bid on Major Rehabilitation Project HH#10435, in the amount of \$31,960.00.

During the course of the construction it was determined that the porch was a safety hazard due to leakage and weathered damage. Rodriguez Constructions, Inc. submitted a quote for the porch replacement in the amount of Three Thousand dollars and no/100's (\$3,000.00). Community Services would like to increase the original contract amount of \$31,960.00, by \$3,000.00 for a new total contract amount of Thirty-four Thousand, Nine Hundred and Sixty dollars and no/100's (\$34,960.00) to cover the cost of replacing the porch.

Amendment No. 1 to Service Agreement 092215-1 will serve to increase the contract amount by an amount of Three Thousand dollars and no/100's (\$3,000.00) for a new total contract amount of \$34,960.00.


Contractor will continue to bill for services pursuant to the Fee and Schedule of the original Service Agreement, but in no event shall charges for the September 23, 2015 to November 27, 2015 contract term exceed \$34,960.00 without prior written agreement of the County.

All other terms and conditions of the original agreement shall remain in full force and affect during the September 23, 2015 to November 27, 2015 term of the contract.
