The state's proposed amendment, section 32.7, adds a new concept: that services may be provided *outside* of Gila County. A.R.S. § 11-254.04 allows for economic development activities outside of the county, however, the assistance must still be found and determined to benefit the inhabitants of the county. I attempted to add some language to bring that requirement into the agreement but the state doesn't want to make any changes now.

For this reason, I am unable to approve the agreement as to form.

A Contractor may request, and the Department may approve, the coordination and provision of emergency assistance outside the designated geographic service area for a specified timeframe if. No amendment to the contract shall be required. Contractor will not make a request to the Department, unless Contractor, pursuant to A.R.S. § 11-254.04, has found and determined that the assistance will assist in the creation of jobs or will otherwise improve or enhance the economic welfare of the inhabitants of Gila County.
