RE: Consideration for Spillman Technologies as a Sole Source, non-competitive procurement contract.

Gila County Board of Supervisors:

The Gila County Sheriff's Office is requesting to bring Spillman Technologies under a Sole Source, non-competitive procurement contract. This agreement will provide a common platform for the Sheriff's Office Records Management System.

The Gila County Board of Supervisors first entered a contract with Spillman Technologies in December 1999, on behalf of the Sheriff's Office. Spillman has met the County's public safety information management needs. Since 1999, the Gila County Sheriff's Office has expanded its Record Management System with Spillman. Spillman currently provides software and support for the following modules: CAD, Jail Management, Records Management, Traffic Management, Arizona State Link, InSight, Property and Evidence, Pin Mapping, Geobase, Civil Processing, Equipment, Imaging, E9-1-1 Interface, and Mobile.

If Spillman technologies is not considered for a sole source, non-competitive contract the County would have to renegotiate the entire contract which would cost several hundred thousand dollars to replace and we would lose all the money that the County has invested in our system for the last 15 years. If we decided to go to bid on pieces of the system we would have compatibility and maintenance issues if Spillman was not the successful bidder.

It is the recommendation of the Gila County Sheriff's Office to stay with our current Records Management System provided by Spillman Technologies and place them under a Sole Source, Non-competitive procurement contract.
