Pursuant to the Terms and Conditions, Amendments or Modifications section and Levels of Service section, the purpose of this amendment is to:
Funding for the contract period July 1, 2015 through June 30, 2016:
The reimbursement ceiling for the service Case Management is increased from \$301,731 to \$315,971. This is an increase of \$14,240.00.
The reimbursement ceiling for the service Community Services is increased from \$150,000 to \$159,545. This is an increase of \$9,545.
The cumulative reimbursement ceiling for the contract period July 1, 2015 through June 30, 2016 is \$475,516.
Therefore, the Itemized Service Budget for the services of Case Management (Attachment A) and Community Services (Attachment B) are revised and attached.
