It is unlawful to sign this petition before it has a serial number. PAID CIRCULATOR VOLUNTEER

THE RIM TRAIL DOMESTIC WATER IMPROVEMENT DISTRICT proposes to increase the size of the BOARD OF DIRECTORS from three (3) to five (5) members. (A.R.S. §48-1012.F)

Initiative Measure to be Submitted Directly to Electors

We, the undersigned, citizens and qualified electors of the state of Arizona, respectfully demand that the following proposed law (or amendment to the constitution, or other initiative measure), shall be submitted to the qualified electors of the state of Arizona (county, city or town of Rim Trail Domestic Water Improvement District) for their approval or rejection at the next regular general election (or county, city or town election) and each for himself says: I have personally signed this petition with my first and last names. I have not signed any other petition for the same measure. I am a qualified elector of the state of Arizona, county of (or city or town and county of, as the case may be) Rim Trail Domestic Water Improvement District.

It is a class 1 misdemeanor for any person to knowingly sign an initiative or referendum petition with a name other than his own, except in a circumstance where he signs for a person, in the presence of and at the specific request of such person, who is incapable of signing his own name because of physical infirmity, or to knowingly sign his name more than once for the same measure, or to knowingly sign such petition when he is not a qualified elector.

Instructions for Circulators

1. All petitions shall be signed by circulator.
2. Paid circulators, whether a resident of Arizona or another state, circulating for a statewide initiative shall register with the secretary of state before circulating petitions.
3. Circulator is not required to be a resident of this state but otherwise must be qualified to register to vote in this state and, if not a resident of this state, shall register as a circulator with the secretary of state.
4. Circulator's actual residence address or, if no street address, a description of residence location shall be included on the petition.


