



AMENDMENT NO. 4 to SERVICE AGREEMENT NO. 082114

The following amendments are hereby incorporated into the agreement for the below project

EQUIPMENT AND VEHICLE WINDOW AND WINDSHIELD REPAIR

AUTO EQUIPMENT MAINT. SHOP-STAR VALLEY

Effective September 17, 2014, Gila County and Glass Masters, Inc. entered into a contract whereby Glass Masters, Inc. agreed to provide Equipment and Vehicle Window and Windshield Repair for the Star Valley Maintenance Shop.

Amendment No. 1 to Service Agreement No. 082114 was executed on August 19, 2015 to increase the original contract amount of Eight Thousand dollars and no/100's (\$8,000.00) by One Thousand dollars and no/100's (\$1,000.00), for a new amended contract amount of Nine Thousand dollars and no/100's (\$9,000.00), to cover the added cost of repairs to vehicles and equipment performed during the contract term, September 17, 2014 to September 16, 2015.

Amendment 2 to Service Agreement No. 082114 was executed on September 09, 2015 extending the term of the contract from September 17, 2015 to September 16, 2016, with a not to exceed contract amount of Nine Thousand dollars and no/100's (\$9,000.00), ***if required and as requested***, without prior written agreement of the County.

Amendment No. 3 to Service Agreement No. 082114 was executed on March 09, 2016 to increase the amended contract by Seven Thousand dollars and no/100's (\$7,000.00), for a new, not to exceed without prior written agreement of the County, total amended contract amount of Sixteen Thousand dollars and no/100's (\$16,000.00), ***if required and as requested***.

Service Agreement No. 082114 expires on September 16, 2016. Per Page 6 Article 14-Term, of the contract, the County shall have the right, at its sole option, to renew the contract for two (2) additional one (1) year periods.

Amendment 4 to Service Agreement No. 082114 will allow for Gila County to exercise the option to renew the term of the Agreement for one (1) one (1) year term, from September 17, 2016 to September 16, 2017, with a not to exceed contract amount of Sixteen Thousand dollars and no/100's (\$16,000.00), ***if required and as requested***, without prior written agreement of the County.

All other terms, conditions and provisions of the original Contract, shall remain the same and apply during the September 17, 2016 to September 16, 2017 renewal period.

IN WITNESS WHEREOF, two (2) identical copies of this amendment, each which shall include original signatures and for all purposes be deemed an original thereof, have been duly executed by the parties hereinabove named, on this 31st day of August, 2016.


