**NOW, THEREFORE,** the Gila County Board of Supervisors hereby issues this Declaration of Emergency in Gila County and the Chairman of the Board of Supervisors is hereby authorized to take all further actions as may be necessary or appropriate to implement this declaration pursuant to A.R.S. § 26-311.
