A RESOLUTION OF THE BOARD OF SUPERVISORS OF GILA COUNTY, ARIZONA, ISSUING A DECLARATION OF EMERGENCY DUE TO THE WOODBURY FIRE THAT STARTED ON SATURDAY, JUNE 8, 2019, IN THE SUPERSTITION WILDERNESS, NORTHWEST OF SUPERIOR, ARIZONA, AND NOW IMPACTS THE ROOSEVELT COMMUNITY IN GILA COUNTY; AND AUTHORIZING THE CHAIRMAN OF THE BOARD OF SUPERVISORS TO TAKE ALL FURTHER ACTIONS AS MAY BE NECESSARY OR APPROPRIATE TO IMPLEMENT THIS DECLARATION PURSUANT TO ARIZONA REVISED STATUTE (A.R.S.) § 26-311.

WHEREAS, the Gila County Board of Supervisors is authorized by A.R.S. §26-311 to declare an emergency exists due to wildfires which endangers life or property within the city, or the unincorporated areas of the County; and

WHEREAS, the Woodbury Fire that started on June 8, 2019, has created an emergency where many citizens may have to evacuate their homes, and there is a threat of damage to their homes, livestock/animals and property; and,

WHEREAS, multiple jurisdictional resources are on the ground expending resources to assist in notifying visitors in the recreational areas of Roosevelt Lake and the local residents in the Roosevelt community of the potential threat, and preparing for the evacuation of visitors and residents;

NOW, THEREFORE, the Gila County Board of Supervisors hereby issues this Declaration of Emergency in Gila County and the Chairman of the Board of Supervisors is hereby authorized to take all further actions as may be necessary or appropriate to implement this declaration pursuant to A.R.S. § 26-311.
