#### **RESOLUTION NO. 21-06-04**

A RESOLUTION OF THE BOARD OF SUPERVISORS OF GILA COUNTY, ARIZONA, ISSUING A DECLARATION OF EMERGENCY DUE TO THE BACKBONE FIRE THAT STARTED ON WEDNESDAY, JUNE 16, 2021, IN THE TONTO NATIONAL FOREST 12-MILES WEST OF STRAWBERRY, GILA COUNTY, AND NOW IMPACTS THE TOWNS OF PINE AND STRAWBERRY, AND THE BLEVINS FIRE THAT STARTED ON FRIDAY, JUNE 18, 2021, AT THE HIGHWAY 188 AND HIGHWAY 288 JUNCTION SOUTH OF ROOSEVELT, GILA COUNTY, IMPACTING RESIDENTS OF THAT AREA; AND AUTHORIZING THE CHAIRMAN OF THE BOARD OF SUPERVISORS TO TAKE ALL FURTHER ACTIONS AS MAY BE NECESSARY OR APPROPRIATE TO IMPLEMENT THIS DECLARATION PURSUANT TO ARIZONA REVISED STATUTE (A.R.S.) § 26-311.

**WHEREAS**, the Gila County Board of Supervisors is authorized by A.R.S. § 26-311 to declare an emergency exists due to wildfires which endangers life or property within the city or the unincorporated areas of the County; and,

**WHEREAS**, the Backbone Fire that started on June 16, 2021, has created an emergency where evacuation orders have been issued and there is a threat of damage to homes, livestock/animals and property; and,

**WHEREAS,** the Blevins Fire that started on June 18, 2021, has created an emergency in the area of Highway 188 and the Highway 288 junction, south of Roosevelt, which is impacting residents of the area; and.

**WHEREAS**, multiple jurisdictional resources are on the ground expending resources to assist in evacuations and sheltering; and,

**WHEREAS**, the Backbone Fire and the Blevins Fire have the potential to impact our Gila County communities and damage County infrastructure and forecasted monsoon rains may have future impacts on County roadways and private properties;

**NOW, THEREFORE,** the Gila County Board of Supervisors hereby issues this Declaration of Emergency in Gila County, and the Chairman of the Board of Supervisors is hereby authorized to take all further actions as may be necessary or appropriate to implement this declaration pursuant to A.R.S. § 26-311.
